

Network Infrastructure Strategy

A rolling 20-year strategy to transform the NSW electricity network



EnergyCo's primary statutory function is *"to investigate, plan, coordinate and carry out the planning and design"* of generation, infrastructure as well as the construction and operation of storage and network infrastructure.

As Infrastructure Planner, EnergyCo acts in three ways for the practical coordination of transmission with generation and firming infrastructure:

plans and procures major network infrastructure projects to unlock additional network capacity across the state



designs and manages network access schemes to ensure new generators can get connected and stay connected



coordinates local community engagement to support joined-up delivery of major infrastructure and benefits



Central West Orana Key features

New transmission infrastructure, energy hubs and switching stations to connect renewable energy generator projects in the REZ to the NSW transmission network.

Key features include:

- Around 90Km of 500kV transmission lines
- Around 150 km of 330 kV transmission lines
- Energy hubs at Merotherie and Elong Elong
- 13 switching stations for 330kV network
- 1 switching station for 500kV network
- Road and intersection upgrades
- Maintenance facility
- Two workforce accommodations camps
- Multiple compounds and access tracks







Central West Orana planning approval achievement

420 submissions made on the EIS



The CWO REZ transmission project was given NSW Planning approval on 26 June 2024, 18 months following receipt of SEARs in October 2022.

The EPBC approval is expected 8 August 2024, six weeks following NSW approval as per the Assessment Bilateral.

This is a key achievement considering:



the alignment continually evolved throughout the environmental planning process in response to landowner, generator and network operator requirements

large community and stakeholder interest in the project, with





89% of the biodiversity study area was surveyed, avoiding large areas of native vegetation

94% of the heritage study area was surveyed and high value Aboriginal and historic heritage sites avoided

Whole-of-Government REZ coordination and delivery

EnergyCo is also partnering with agencies to deliver the Roadmap's supporting infrastructure in ways that address emerging supply chain risks and secures long-term benefits for host communities

Roads and transport – 2000 85m+ turbine blades are expected to need transport from ports to CWO REZ alone

MoU with TfNSW to coordinate and plan for road upgrades and operational considerations in ways that also benefit host communities

Housing – up to 10,000 workers will need accommodation over next ten years

EnergyCo is working with Regional NSW and housing agencies to identify opportunities for new worker accommodation that could also meet social and affordable housing needs in regional areas

Telecoms – Mobile and data network upgrades are needed to facilitate large scale and often remote construction and operation

EnergyCo is considering a proposal from the NSW Telco Authority to improve telecommunications services for both transmission developers and regional communities.


Port to REZ Program





The Port to REZ Program is designed to enable the **timely, efficient, and successful delivery** of key components required for the construction of critical REZ infrastructure.

- Port of Newcastle and the Golden Highway will transport the majority of components for most energy projects in NSW
- On time delivery of those components is a key dependency for all projects
- EnergyCo and Transport for NSW are coordinating the design, approvals, and delivery of the Port to Paddock State road upgrades to meet critical path dates for CWO project schedules. This will also assist all other projects
- This includes:
 - development of a renewable energy logistics hub at PoN to facilitate the storage and logistics of OSOM components after import
 - Work with projects and Councils for project specific upgrades to local roads



Community and Employment Benefit Program Central West Orana



The *Electricity Infrastructure Investment Act 2020* (the EII Act) requires components of REZ access fees to be used for a "community purpose" and an "employment purpose" (ss 26[2] and [4]) and gives EnergyCo, as the infrastructure planner in a REZ with a declared access scheme, a function to administer, manage and make payments of money held for these purposes (cl 42D of the *Electricity Infrastructure Investment Regulation 2021*).

The **Community and Employment Benefit Program** (the Program) provides the framework for how EnergyCo administers access fees for community and employment purposes across REZs within a declared access scheme.



Community and Employment Benefit Program Program launch and next steps



The Program was launched on 15 July 2024 will be delivered in the CWO REZ two stages - **Stage 1** will launch imminently with grant streams totalling **\$70.5 million**, with **Stage 2** likely following towards the end of the 2024/25 financial year.

Following launch, EnergyCo has commenced development of the Program in other REZs, including the New England and South West REZ, with remaining **\$57.9 million** funding to be announced dispersed in the CWO REZ by the end of 2028.
